- Vendor application and payment are due no later than **May 1, 2018**
- Vendors will be advertised on the Pathfinder Village Splash Path Vendor page, as applications and payment are received.
- Vendors will provide all items needed for their display, including tent/coverage and table. Electricity is available on a limited basis.
- Set up location will be on the west side of the Village near the Finish Line & Pavilion, where all ending events will take place
- Set up time: Saturday, May 19, 2018, 6:30 am to 8:00 am
- Vendor Run Time: Saturday May 19, 2018, 9:00 am to 1:00 pm
- **This is an outdoor event and will run rain or shine**

Early entry fees are:

- Family (3+ immediate family members): \$45
- Adults (19 and up): \$20
- Youths (10-18): \$10
- Children (6-9): \$5
- Kids (5 & under): Free

**** On May 6, registration fees increase by \$10; registration for Kids goes to \$5.**

The maximum Family Registration Fee is \$55.**



VENDOR TERMS AND CONDITIONS

All vendors' space must be unconditionally **PAID IN FULL by May 1, 2018**. In submitting this contract, the vendor agrees that **Pathfinder Village may reassign any space not paid in full by May 1, 2018**. Vendors further agree to abide by the terms and conditions as set forth below, which forms a part of this agreement between the vendor and Pathfinder Village. The Individual Party named will be responsible for payment in full for all area(s) requested in this contract. All vendor applications will be accepted based on the products displayed and may be rejected by Pathfinder Village at any time during the application process.

1. Terms and Conditions; Release and Waiver

Pathfinder Village reserves the right to alter the floor plan and/or reassign exhibit location without notice, regardless of the space of the area assigned. Pathfinder Village has provided a public venue for a large number of persons to attend. Pathfinder Village does not make any guarantee as to the number of visitors who will attend the event nor the exposure that the vendor will achieve. The vendor, on behalf of itself, its employees, agents, and representatives, waives, releases and holds harmless Pathfinder Village, its affiliates, and their employees, representatives, contractors or agents, from and against any and all claims, losses or damages arising from or relating to the Splash Path, including without limitation, any claims, losses or damages arising from low visitor turnout and/or lack of vendor exposure, loss, theft, damage, or destruction of any personal property, bodily injury or wrongful death. Vendor agrees to hold harmless Pathfinder Village, its affiliates, and their employees, representatives, contractors or agents, from and against any and all claims of any person arising out of acts, omissions, or negligence of Pathfinder Village, its employees, representatives, contractors and agents.

2. Eligible Products or Services

Vendor agrees to advertise and/or display only products or services consistent with the family-friendly theme of Splash Path. Pathfinder Village reserves the right to determine the eligibility of any company, product or service to exhibit at the Event. Literature and handouts will be permitted.

3. Insurance

A vendor who desires insurance for their exhibits while in transit and at the Splash Path must purchase this insurance at their own expense. Vendor bears all risk of loss and damage to or theft of its property.

4. Installation of Exhibits

Set-up times must be adhered to strictly as traffic will be a problem after **8:00 am**. Your area must be ready by **8:30 am** on **May 19, 2018**. Failure to show or have your area attended and ready will require Pathfinder Village to eliminate it altogether.

5. Dismantling by Exhibitor

All Exhibitors must keep their area attended, and their area must remain intact until at least 1:00 pm, and may not be packed or moved until such time. The raffle auction drawings will be at 1:00 pm. All Exhibitors must exit the premises with displays and products completely removed by **3:00 pm** on May 19, 2018.

6. Failure to Occupy Space; Payment in Advance

Space assigned to a vendor must be paid for, in full, by **May 19, 2018** or Pathfinder Village may terminate this contract and reassign the space to another vendor. If vendor does not claim or occupy assigned space during Splash Path, Pathfinder Village may, at its option, terminate this agreement and reassign the space. In neither case shall the defaulting vendor be entitled to the refund of any sums paid in advance to Splash Path or Pathfinder Village.

7. Vendor's Cancellation Rights

The Vendor may cancel this contract at any time upon written notice to Splash Path. If a written cancellation notice is received by Pathfinder Village 30 days prior to Splash Path, then the Vendor shall be entitled to a full refund of all monies paid. Cancellations that are not in writing **will not** be honored. Cancellations that occur less than 30 days before Splash Path will not be honored, with the Vendor forfeiting 100% of all monies paid to Pathfinder Village.

8. Rules and Regulations.

The Vendor must comply with the Rules and Regulations provided by Pathfinder Village. Vendor's failure to comply with the applicable Rules and Regulations shall result in termination of this contract without refund and removal of Exhibitor from the Event.
